BY THE GRACE OF ALMIGHTY GOD

THE REGENT OF REMBANG,

- Having considered :
- a. that every person has the right to social security to be able to fulfill the basic needs of a decent life and increase their dignity towards the realization of a prosperous, just and wealthy Indonesian society under Pancasila and the 1945 Constitution of the Republic of Indonesia;
 - b. that in order to improve the welfare of the community and to maintain the quality and continuity of the national health security program, the synergy is needed in funding and health services;
 - c. that the Regent Regulation Number 13 of 2016 on Integration of the Rembang Sehat Health Security in the Regency of Rembang into the National Health Security Program is no longer appropriate and needs to be amended;
 - d. that based on the considerations as referred to in paragraphs a, b, and c, it is necessary to issue a Regent Regulation on Implementation of the National Health Security Program by the Local Government through the Social Security Agency for Health;

- Having regard to :
1. Article 18 paragraph (6) of the 1945 Constitution of the Republic of Indonesia;
 2. Law Number 13 of 1950 on Establishment of Regency Areas within the Province of Central Java (Official Gazette of the Republic of Indonesia Year 1950 Number 45);
 3. Law Number 23 of 2014 on Local Governments (State Gazette of the Republic of Indonesia Year 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587) as repeatedly amended and most recently amended by Law Number 6 of 2023 on Enactment of Government Regulation in Lieu of Law Number 2 of 2022 on Job Creation to

become Law (State Gazette of the Republic of Indonesia Year 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);

DECIDES:

To issue : REGENT REGULATION ON IMPLEMENTATION OF THE NATIONAL HEALTH SECURITY PROGRAM BY THE LOCAL GOVERNMENT THROUGH THE SOCIAL SECURITY AGENCY FOR HEALTH.

CHAPTER I
General Provisions

Article 1

In this Regent Regulation:

1. Region means the Regency of Rembang.
2. Local Government means the Regent and Regional Apparatus as elements of the Local Government Administration.
3. Regent means the Regent of Rembang.
4. Social Security Agency for Health (*Badan Penyelenggara Jaminan Sosial Kesehatan*), hereinafter abbreviated to BPJS Kesehatan, means a legal entity formed to administer the health security program.
5. Health Security means a security in the form of health protection so that Members receive health care benefits and protection in fulfilling basic health needs which is provided to every person who has paid Health Security Contributions or whose Health Security Contributions are paid by the Central Government or Local Government.
6. Health Security Contribution, hereinafter referred to as Contribution, means an amount of money paid regularly by members, employers, and/or the central government or local government for the health security program.
7. Contribution Assistance Recipient (*Penerima Bantuan Iuran*), hereinafter abbreviated to PBI JK, means a person who living in poverty as a member in the national Health Security whose premium are paid by the central government.
8. Destitute Person means a person who has no source of livelihood at all and/or has a source of livelihood but does not have the ability to fulfill the basic needs for a decent life for him/herself and/or his/her family.
9. Social Welfare Service Recipient (*Pemerlu Pelayanan Kesejahteraan Sosial*), hereinafter abbreviated to PPKS, means an individual, family, group member and/or certain community who, due to an obstacle, difficulty or disturbance, cannot carry out his/her social function, so that his/her physical, spiritual and social need cannot be met adequately and reasonably.

Article 2

- (1) This Regent Regulation is intended as a guideline for providing Health Security Contribution assistance for PPKS.

- (2) This Regent Regulation aims to ensure the continuity and improvement of access to health services for PPKS.

CHAPTER II RESPONSIBILITIES OF LOCAL GOVERNMENT

Article 3

- (1) The Local Government ensures that all residents are registered as members in the national Health Security program.
- (2) The Local Government provides assistance in paying contributions for the national Health Security program to PPKS.
- (3) The PPKS as referred to in paragraph (1) consists of:
 - a. abandoned children;
 - b. street children;
 - c. abandoned older adults;
 - d. persons with disabilities;
 - e. persons having no home;
 - f. beggars;
 - g. waste pickers;
 - h. persons with HIV/AIDS (*orang dengan HIV/AIDS, ODHA*);
 - i. victims of violence;
 - j. socio-economically vulnerable women; and/or;
 - k. destitute persons.
- (4) PPKS as referred to in paragraph (1) may be given contribution assistance with the following criteria:
 - a. residents of the Regency of Rembang;
 - b. level of family welfare; and
 - c. non-PBI.

CHAPTER III REGISTRATION MECHANISM FOR RECIPIENTS OF CONTRIBUTION ASSISTANCE

Article 4

- (1) PPKS who wish to receive assistance in paying contributions for the national Health Security program submits a registration application to the Head of the Social Services, Women's Empowerment and Family Planning Service located at the Public Service Mall.
- (2) The application as referred to in paragraph (1) is accompanied by:
 - a. photocopy of Resident Identity Card and photocopy of Family Card which states that you are a resident of Rembang; and
 - b. a letter of confirmation of citizen status from the Village Head or Urban Village Head.

Article 5

- (1) The Head of the Social Affairs, Women's Empowerment and Family Planning Office verifies the application as referred to in Article 4 paragraph (1).
- (2) Verification as referred to in paragraph (1) ensures that the recipient is not included in the PBI JK recipient.

- (3) The Head of the Social Affairs, Women's Empowerment and Family Planning Office provides a recommendation to the applicant as a recipient of assistance for the national Health Security program contributions with evidence in the form of a recommendation letter.
- (4) The format of the recommendation letter as referred to in paragraph (3) is listed in the Annex which constitutes an integral part of this Regent Regulation.

Article 6

- (1) PPKS submits an application for registration as a JKN (*Jaminan Kesehatan Nasional*, National Health Security) member to the Head of the Health Office by submitting a recommendation letter from the Head of the Social Affairs, Women's Empowerment and Family Planning Office.
- (2) The Head of the Health Office submits PPKS registration to BPJS Kesehatan.

CHAPTER IV FUNDING

Article 7

- (1) The Health Office allocates Health Security Contributions to the Regional apparatus work plan.
- (2) The amount of allocation as referred to in paragraph (1) is adjusted to the amount of contributions determined by the central government.

Article 8

Funding for the implementation of the National Health Security program for PPKS in the Region comes from:

- a. Local budget; and/or
- b. other legitimate sources in accordance with the provisions of laws and regulations.

CHAPTER V DATA RECONCILIATION

Article 9

- (1) The Social Affairs, Women's Empowerment and Family Planning Office, Population and Civil Registry Office, and the Village/Urban Village Governments update target data every month per person per address to ensure accurate and up-to-date data.
- (2) The results of the updates as referred to in paragraph (1) are submitted to the Health Office to carry out periodic data reconciliation within a certain time period with BPJS Kesehatan.

CHAPTER VI SUPERVISION AND CONTROL

Article 10

- (1) The Local Government together with BPJS Kesehatan carry out supervision and control of the implementation of the Health Security program in the Region.

- (2) Supervision and control of the implementation of the Health Security program by the Local Government as referred to in paragraph (1) is carried out through:
 - a. routine checks; and
 - b. direct supervision.
- (3) Supervision and Control of the implementation of the Health Security program by the Local Government as referred to in paragraph (1) is carried out in accordance with the provisions of laws and regulations.

CHAPTER VII CLOSING PROVISIONS

Article 11

Upon the entry into force of this Regent Regulation, the Regent Regulation of Rembang Number 13 of 2016 on Integration of the Rembang Sehat Health Security of Rembang Regency into the National Health Security Program (Regional Official Gazette of the Regency of Rembang Year 2016 Number 13) is hereby repealed and declared to be no longer in force.

Article 12

This Regent Regulation shall enter into force as of the date of its promulgation.

In order to make this Regent Regulation known to the public, it is hereby ordered that it be promulgated by its publication in the Regional Official Gazette of the Regency of Rembang

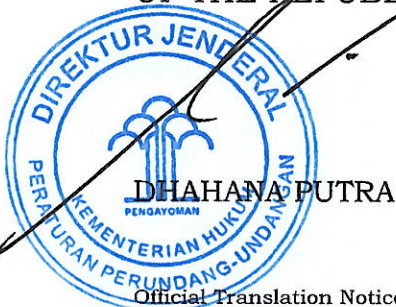
